ISTA Foundation License Plate

Last year at an Executive Committee meeting of the Retired Council, ISTA-Retired Secretary Terry Tafflinger proposed an idea that we apply for a State License Plate for the ISTA Foundation with the fees going to ISTA Scholarships. The proposal was brought before the Retired State Council, and they voted to recommend to the ISTA Board of Directors the proposal. The ISTA-Retired recommendation included that Retired would manage the qualification process and that the first \$5,000 collected would go to the Retired Student Scholarship. The Board agreed and Retired began circulating petitions. One hundred petitions with over 650 signatures were collected and the documentation and application were completed by the April 1st deadline.

We received word from the Bureau of Motor Vehicles (BMV) that we had properly completed our application and that the Roads and Transportation Committee would meet sometime in September or early October to vote on passage of the application. The Roads and Transportation Committee met on September 22nd and heard testimony. Terry Tafflinger testified for the ISTA Foundation. She emphasized that the fees collected from the plate would all go to scholarships. Ironically, the State only allows five new specialty plates each year and there were just five applicants. After testimony, the committee decided to vote later which was on October 20th. I am excited to announce that the committee voted to grant our plate!

When you renew your license plates, you will be able to select the new ISTA Foundation plate beginning in January. As you know, the date of your renewal is based on a staggered monthly requirement. We hope that you will want to take part in this exciting process and help provide scholarships to our ISTA members' children, grandchildren, stepchildren, etc. Also, as is the case, the specialty plate qualifies as a 501c3 for a tax deduction. The plate design is pending before the BMV for approval and it will be publicized as soon as it is approved. We just completed our annual Retired Conference in Indianapolis on October 9th. It was well attended with 48 attendees and conference presenters. At the conference State Senator Rod Pol discussed the happenings in the legislature. He gave us great insight into the coming session.

Your Retired Legislative Committee is planning the lobbying for the next session to begin in January. As you all know, we received a 13th check with a 5% reduction in September. However, there were not any appropriations for any pension increase in the second year of the budget. HEA 1221 pushed the date of the permanent beginning of a pension increase from July 1, 2025, to July 1, 2029. The Retired Legislative team will be working to see that some type of increase occurs in September 2026. We will be asking you to help in contacting your legislators as you have in the past. We will announce a Retired Day of Action (Lobby Day) sometime in late December or early January.

Our State Council meeting will be held on November 4th at our Intech ISTA Office. We will receive reports from our Retired Committees and the ISTA Standing Committees. All chapter representatives on the Council present those reports at their chapter meetings. If you are not involved in a chapter, I would encourage your attendance. This *Chalkboard* and all issues include pictures and stories about their meetings.

October 8-9, 2025, retired members attended a two-day conference at the ISTA Intech Conference Center in Indianapolis. The conference started with a welcome from Retired Council Chair Rod Ellcessor and an icebreaker following where members introduced

Recipe Corner

Swedish Meatballs

1 pound of ground beef
1 beaten egg
2/3 can of PET evaporated milk
1/4 tsp. nutmeg allspice
2T chopped onion

1/2 cup breadcrumbs1 T brown sugar1 can Cream of Mushroom Soup-topping

Mix and roll into balls, brown in pan. Either continue cooking on top of stove OR after browning put in a baking dish and continue in oven till done. Either way, top with a can of Cream of Mushroom till heated completely. Bake at 375 degrees if using the oven. Lower temperature if delaying till later.

A self-taught crafter, Terry is admired for her crafting in card making, wedding invitations, decorations, and centerpieces. She also crochets baby blankets. Terry stated that while teaching, crafting was a great stress reliever after grading papers and she tried to set aside time every evening for this. She plays the organ for her own pleasure, a skill she learned as a child; she is an avid Notre Dame fan and enjoys a good "Green Frog" victory drink (like a grasshopper made with ice cream) to celebrate the wins; and what is it that gets her through trying days? Terry replied, "It is what it is so make the best of it."

Terry believes continued involvement helps to keep Steve's legacy alive. ISTA-RETIRED ELECTION GUIDELINES

Below are the two-year term election guidelines for the 2026 and 2027 ISTA Representative Assembly (RA) retired delegates and alternates and NEA RA retired delegates and alternates. For 2026, the ISTA RA will be held on April 18, 2026; the NEA-Retired Annual Meeting will be June 30- July 1, 2026, and the NEA RA on July 3-7, 2026, in Denver, Colorado. The 2027 NEA Representative Assembly will be held in Indianapolis, IN, from July 1-5. These procedures have been developed by the ISTA-Retired Executive Committee and approved by the ISTA-Retired District Council.

The guidelines are as follows:

NOMINATION RULES

- 1. There will be a period of open nominations of candidates for ISTA RA retired delegates and NEA RA retired delegates (terms stated above and below).
- 2. Only ISTA-Retired members who have retired from their education positions are eligible to participate in the nomination and election of the open positions listed above.
- 3. The **Retired Petition for Nominations** and the **Election Procedures for 2026 and 27 terms** will be printed in the fall Advocate and delivered to retired members' mailboxes. The election procedures will also be printed in the retired newsletter, The Chalkboard, and posted on the ISTA website.
- 4. Nomination petition forms printed in the fall Advocate may be cut out or copied from the Advocate. The form must be signed by the nominee. ISTA will verify your membership ID number. Nominees may list three qualifications and any such statements must be six words or fewer.
- 5. The petition of nomination must be returned to the Office of ISTA-Retired, Attn: ISTA-Retired Candidate Nomination, 150 W. Market St., Suite 900, Indianapolis, IN 46204-2875, and must be postmarked on or before midnight, November 7, 2025, or hand-delivered no later than November 7, 2025, 4:30 p.m. ET to the office of ISTA-Retired.
- 6. Persons whose nominations are received by the Office of ISTA-Retired, as stipulated above, shall constitute the properly certified nominees.

CAMPAIGN RULES

- Following the close of the nominations on **November 7, 2025**, the names of all candidates and three listed qualifications will be printed in the winter Advocate along with the ballot and mailed to all ISTA-Retired members, who have retired.
- 2. The official mailing list of the eligible ISTA-Retired voters shall be made available upon request to any candidate to be used only for campaigning for the open seats for which they are running. The candidate requesting the lists are responsible for all costs in their campaign.
- 3. Campaign materials may contain references to the candidate's own ethnic heritage.
- 4. No dues money local, district, state or national may be used to promote the candidacy of any individual or groups of individuals running for office.

ELECTION RULES

- The election for ISTA RA retired delegates and alternates, and the NEA RA retired delegates and alternates shall be conducted between January 16, 2026, and February 26, 2026. The election rules will also be posted on the ISTA website and included in the August/September and November/December ISTA-Retired newsletter, The Chalkboard.
- 2. Ballots will be included in the ISTA winter Advocate and mailed in or before February 2026 to all ISTA-Retired members whose membership forms have been processed by ISTA by December 2025.
- 3. The names will be placed on the ballot in the order determined by drawing from a common receptacle by the executive director or designee with appropriate witnesses.
- 4. Each ballot shall contain a list of the properly certificated candidates. No other information about candidates may be legally included on the ballot.
- 5. An eligible member may vote for up to thirty-two (32) ISTA-RA retired delegate candidates and six (6) NEA RA retired delegate candidates. Those candidates, beyond the winning candidates, shall be ranked in order and serve as alternates. Any ballot on which more votes appear than the total allowed shall not be counted.
- 6. Ballots must be returned in the official ballot envelope included in the winter Advocate marked ISTA-Retired Ballot. <u>ISTA-RETIRED MEMBERS ARE REQUIRED TO PLACE THEIR NAME AND RETURN ADDRESS ON THE ENVELOPE TO MAKE MEMBERSHIP VERIFICATION POSSIBLE. IF NO NAME IS PLACED ON THE ENVELOPE CONTAINING THE BALLOT, IT WILL VIOLATE THE RULES AND NOT BE COUNTED.</u>
- Only those official ballots meeting the rules, and which are postmarked on or before midnight February 26, 2026, shall be counted.
- 8. After verification of membership, the ballots shall be separated from the mailing envelopes, be tabulated and certified by the designated counting agency.

(ELECTION PROCEDURES CONTINUED)

- 9. The results of the election shall be determined by the above agency in the following manner:
 - All candidates for ISTA RA retired delegate and NEA RA retired delegate will be ranked in order (identified below), with two-year terms as follows:
 - ISTA RA retired delegate for the 2026 and 2027 meetings.
 - NEA RA retired delegate for the 2026 and 2027 meetings.
- 10. The certified ISTA RA retired and NEA RA retired representatives shall be notified of his/her rank order in writing as soon as possible after the results are known.
- 11. The ballots shall be impounded by ISTA for two (2) years.

CHALLENGE RULES

- Any challenge to these rules or any activity or result governed by them shall be submitted in writing to the Chairperson of the Elections Committee, in care of the Indiana State Teachers Association, 150 W. Market St., Suite 900, Indianapolis, IN 46204-2875, by March 15, 2026.
- 2. If necessary, the ISTA Elections Committee will meet as soon as possible after receiving such challenge to review and act upon any submitted challenges. Any Elections Committee member who is a candidate for a position involved in a challenge shall be ineligible to participate as an Elections Committee member in the pertinent deliberations.
- 3. The executive director or designee will notify the appropriate party of the action of the Elections Committee.
